

ZONE: **RED - CONTROL**

The Town of New Tecumseth is restricting the use and availability of its recreation centres for residents who reside in the areas that the Province has moved into a more stringent category than what New Tecumseth is currently in.

The Town is currently in the **RED – CONTROL** and will be restricting access to our facilities for those currently in the **GREY - Lockdown**. Please note proof of I.D is required for all new rental permit holders.

Provincial Guidelines: **RED – CONTROL**

- **Maximum 10 players plus 2 Coaches & 1 Trainer**
- **NO Games or Scrimmages permitted**
- **Spectators are NOT permitted** (exemption parent/guardian, can enter facility to assist player with equipment however must exit the facility immediately).
- **Changerooms are not available.**
- **Water fountains and Showers are not available** - Please bring a pre-filled water bottle.
- **Masks are mandatory** for all indoor public spaces for those 2 years of age or older and may only be removed while on the sporting surface. Coaches/instructors who are not on the sporting surface, **MUST** wear a mask.
- **Contact Tracing and Covid-19 screening is mandatory to be submitted to Town Facility Staff upon entry.**

Attending your permit:

- Participants are to arrive fully dressed for their activity.
- To ensure facility capacities are adhered the Permit holder will escort their attendees into the facility 15 minutes prior to the permitted start time where contact tracing information and COVID-19 screening will be reviewed with all attendees.
- Please dress appropriately for the outside weather conditions while waiting to enter the facility or remain in your vehicle until your designated screening time.
- The Permit holder and/or designate is responsible to ensure the indoor gathering limits within their permitted booking space is adhered to as per Provincial health regulations and guidelines.
- The guardian (per minor) will be directed to exit the facility after assisting the minor with their equipment and will be permitted to enter again at the end of the booking to assist if required.

Attending your permit continued

- Facility signage and physical distancing protocols must be adhered to as per the Provincial Order.
- Upon entry, attendees will be directed to their designated seating area to put indoor shoes on and are to follow the distancing markers in the facility.
- Participants must follow the designated directional signs to enter/exit the arena floor, gymnasium, or fieldhouse.
- When you are booked for more than one hour please confirm with the Facility Staff if you have additional groups arriving.
- Please ensure the following groups within your booking are met by the permit holder/or designate outside the facility 15 minutes prior to the next ice start time and contact tracing has occurred and COVID -19 assessment questions reviewed to the new groups arriving.
- Absolutely no spitting or horseplay at any time. These actions will not be tolerated and could risk the facility permit being terminated. Participants are not to warmup in unpermitted areas of the facility under any circumstances.
- Outside food and beverage is not permitted in the facility.
- Participants must follow the designated distancing markers when using the players benches.
- Access to a washroom for players, coaches and participants will be in the main facility washrooms.

Permit holders not adhering to facility protocols may be denied future facility rentals.
