

ZONE: RED - CONTROL

The Town of New Tecumseth is restricting the use and availability of its recreation centres for residents who reside in the areas that the Province has moved into a more stringent category than what New Tecumseth is currently in.

The Town is currently in the **RED – CONTROL** and will be restricting access to our facilities for those currently in the **GREY - Lockdown**. Please note proof of I.D is required for all new rental permit holders.

Provincial Guidelines: RED – CONTROL

- **Maximum 25 participants outdoors**
- **NO Games or Scrimmages permitted**
- **Spectators are NOT permitted** (exemption parent/guardian, can enter the field/ diamond to assist participant with laces/ equipment however must exit the field/ diamond immediately).
- **Contact Tracing and Covid-19 screening is mandatory to be submitted to the Parks, Recreation & Culture Department via email at rentals@newtecumseth.ca upon entering the field/ diamond.**
- **Masks are mandatory** and may only be removed while on the field or diamond. Coaches/instructors who are not on the field or diamond, **MUST** wear a mask.

Attending your permit:

- Participants are recommended to arrive fully dressed with equipment on.
- Facility signage and physical distancing protocols must be adhered to as per the Provincial Order. All persons must try to remain two meters apart at all times when on the field or diamond.
- The Permit holder and/or designate is responsible to ensure the outdoor gathering limits within their permitted booking space is adhered to as per Provincial health regulations and guidelines. **When determining your gathering numbers please include all involved participants, coaches, trainers etc. who are in attendance during your permitted time.**
- Permit holders and/ or designate are required to meet permitted attendees (participants, coaches, trainers, etc.) at a designated area within the field or diamond space 15 minutes prior to permit start time. This allows the permit holder or designate time to complete contact tracing information and COVID-19 screening with all attendees. Participants must leave the field/ diamond immediately following permit time to ensure organizers can maintain legislated numbers accordingly.
- The guardian (per minor) will be directed to exit the field/ diamond after assisting the minor with laces/ equipment and will be permitted to enter again at the end of the rental to assist the participant if required.

Attending your permit continued ...

- It is the responsibility of the permit holder to ensure they provide hand sanitizer to participants.
- It is the responsibility of the permit holder to ensure mandatory cleaning and sanitization of the bench area following each scheduled game and or practice. The bench area is to be clear of any debris, bottles, and garbage. Garbage from the bench areas is to be disposed of safely and in garbage cans provided by the Town of New Tecumseth.
- It is recommended that organizers schedule **a 15 minute buffer** between all bookings to avoid overlap of participants and allow social distancing guidelines to be adhered to.
- Absolutely no spitting or horseplay at any time. These actions will not be tolerated and could risk the facility permit being terminated.
- Sunflower seeds, chewing tobacco and spitting are not to be engaged at any Town of New Tecumseth field or diamond. It is the responsibility of the permit holder to monitor and supervise this activity during their permitted time.
- Please ensure all groups within your booking are met by the permit holder and/or designate upon entrance to the premises 15 minutes prior to the field/ diamond start time and contact tracing has occurred and COVID -19 assessment questions reviewed.

Permit holders not adhering to facility protocols may be denied future facility rentals.
